On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderman Grimes, Alderwoman Mehl, Alderwoman Smith, Alderwoman Whitmore, Alderman Vaught, Alderman Rhodes, & Alderman Jones. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, & City Attorney Michael Murphy. Alderman Hawkins was not present.

Ordinance Passed:

- O-11-60 Ordinance appropriating funds in the amount of \$1,222,791 for the Farris Road Improvements (Bruce Street to Dave Ward Drive) and \$300,000 for Museum Road Improvements (Siebenmorgan to Lower Ridge Road). **Vote 7-0**
- O-11-61 Ordinance accepting & appropriating grant proceeds in the amount of \$2475 for the Historic District Commission to be administered by the Planning & Development Dept. **Vote 7-0**
- O-11-62 Ordinance appropriating asset forfeiture funds in the amount of \$5,410 to the Conway Police Department. **Vote 7-0**
- O-11-63 Ordinance authorizing a change in staffing levels for the Finance Department. **Vote 7-0**

Resolution Passed:

- R-11-38 Resolution authorizing Conway Corporation to temporarily suspend late payment fees for residential customers. **Vote 7-0**
- R-11-39 Resolution requesting the Faulkner County Tax Collector to place a certified lien on property located at **1515 Freyaldenhoven** as a result of incurred expenses by the City. **Vote 7-0**
- R-11-40 Resolution requesting the Faulkner County Tax Collector to place a certified lien on property located at **2235 Nature Trail Drive** as a result of incurred expenses by the City. **Vote 7-0**
- R-11-41 Resolution requesting the Faulkner County Tax Collector to place a certified lien on property located at **1415 Lincoln Street** as a result of incurred expenses by the City. **Vote 7-0**

In Other Actions:

- Approved the minutes from the July 26th, 2011 City Council Meeting. **Vote 7-0**
- Approved to enter into an agreement with Charlie Bocksnick for testing services of traffic lights conflict monitors. **Vote 7-0**

- Approved to the request from Randy Dryer to an extension (two weeks) of the condemnation order on property located at 912 Front Street. **Vote 7-0**
- Approved to accept bids from Coulson Oil Company for a new fuel card system for the City. **Vote 7-0**

- Consideration of several condemnations for Conway Corporation related to Tupelo Bayou Wastewater Treatment Plant. **Vote 7-0**
